

Ben Chester Cheong is a law academic at the School of Law, Singapore University of Social Sciences (SUSS). Ben is concurrently a consultant lawyer with the Financial Services (Regulatory) Practice at RHTLaw Asia LLP. Ben has received the university-level SUSS Teaching Excellence Award (Winner) in 2022 and the SUSS Teaching Excellence Award (Honourable Mention) in 2021. Ben previously served as an international capital markets and banking & finance lawyer at American law firm, Baker McKenzie, Since 2019, Ben is the course convenor for Law of Business Organisations (LBO), a compulsory module covering the legal aspects of partnership, company and corporate insolvency. Ben is also a course tutor for Contract and Civil Litigation module since 2020 and Equity and Trusts module since 2023. He previously taught Legal Methods and Singapore Legal System module from 2020 to 2022 and Mediation Advocacy in 2022. He designed the syllabus, course guide and study units for Equity and Trusts module from 2018 to 2019. Ben is a facilitator for the Advanced Corporate Practice module at the Part B of the Singapore Bar Examinations. His peer-reviewed papers which have been cited, have appeared or are pending publication in leading international journals, such as International Company and Commercial Law Review, International Cybersecurity Law Review, Company Lawyer, SN Social Sciences, Singapore Policy Journal, Singapore Academy of Law Journal, Asian Journal of Legal Education and Journal of Business Law. He is peer reviewer for The Journal of Financial Crime and the Journal of Money Laundering Control. Ben regularly contributes feature articles to the Singapore Law Gazette and also regularly writes opinion insight pieces for both The Straits Times and The Business Times. Ben holds a Master's degree in Law from the University of Cambridge, a Bachelor's degree in Law (with 1st class honours) (Top 1%) from the University of Exeter, and placed 3rd out of 664 candidates (3 distinctions) (Top 0.5%) in the Singapore Bar Examinations (Part B). He is the highest performing Cambridge graduate in that year's Bar Examinations (Part B). Ben is dualqualified and admitted to practice law in Singapore and England & Wales.
